

Annual Governance Statement for the Governing Board of Hevingham and Marsham Primary School Federation September 2019 to July 2020

In accordance with the Government's requirement for all governing boards, the 3 core strategic functions of Hevingham and Marsham Primary Schools Federation are:

- 1. Ensuring clarity of vision, ethos and strategic direction in order to ensure the best possible outcomes for all pupils**
- 2. Holding the Headteacher to account for the educational performance of the school and its pupils**
- 3. Overseeing the financial performance of the school and making sure its money is well spent.**

Governance Arrangements

- From September 2019 to July 2020 the Governing Board of Hevingham and Marsham Primary Partnership Schools was made up of:
 - 5 Co-opted governors
 - 2 Foundation Trust Governors
 - The Head Teacher
 - 1 LA governor
 - 1 elected parent governors
 - 1 staff governor
- During the year Vicki Millington (parent governor) stepped down and we thank her for all the work and support she gave the governors and schools.
- Vacancies exist for 2 parent and steps are being taken to fill this place
- When appointing governors, we try to ensure that all sections of our community are represented.
- The full Governing Board meet five times a year or more if the need arises.
- The committee structure of the Governing Board from September 2019 has two committees:
 - Leadership and Management Committee - which looks at the effectiveness of leadership and management, outcomes for pupils, personnel, welfare and health & safety
 - Teaching and Learning Committee - which looks at quality of teaching, learning and assessment, personal development, behaviour and safeguarding.
- These committees meet at least once a term and report back to the full Governing Board meetings.
- We also have committees that meet if required. e.g. Appeals Committee.
- The current structure was established in September 2018 following a review in July 2018.

Attendance Record of Governors

Governors have excellent attendance at meetings and we have never cancelled a meeting because it was not "quorate" (the number of governors needed to ensure that legal decisions can be made).

<p>The Work of the Governing Board During this Year</p>	<ul style="list-style-type: none"> • In March 2020 the effect of Covid-19 in the UK resulted in the closure of schools across the UK for all except the children of essential workers and vulnerable children. • In June 2020 the schools were re-opened to Reception, Year 1 and 6 children as well as essential worker children. • The Governing Board has worked closely with and supported the senior leadership team as they navigated the large amount of ever-changing guidance to ensure support for both children and parents. • Throughout this time the focus has been on children’s wellbeing and education and the wellbeing and safety of staff. The Governors have continued to monitor the work of the school through additional on-line meetings. • It has been a challenging time and is likely to continue as we move into the new academic year. • Policies have continued to be reviewed and updated as per the agreed framework and Covid-19 guidance. • The Governing Board reviewed and updated the vision and ethos statement of the school. • The Leadership and Management committee have looked at the budget in line with current county financial challenges and worked hard to ensure that money was allocated across both schools to ensure that the children of Hevingham and Marsham will continue to receive the best education possible in the next academic year. • The Teaching and Learning committee have continued to monitor children’s progress across the subjects, as well as factors that can affect the children such as behaviour and attendance. It also
