#### 6. Sub-Committee Reports

#### **Teaching and Learning Committee**

The Chair of the Teaching and Learning Committee provided a verbal update. It was noted the Committee discussed wellbeing, staff changes and recruitment. It was acknowledged how much time, effort and energy it has taken. It was discussed that behaviour has improved and pupil perception and parent questionnaires are positive with some areas to improve. The Chair commented that the update on Under 5's was very good and informative about their progress and activities.

#### **Management Committee**

The Chair of the Management Committee provided a verbal update from last night's meeting. It was noted that Budget Revision 2 was agreed and concerns were raised on the 3rd year projective deficit and falling pupil numbers, especially at Marsham. It was noted that the Government will provide an outline for additional funding for schools. The Chair noted that the Pay Policy was agreed and a lengthy discussion ensued regarding Pay Policy choices. The committee discussed the RAG rating and governor training.

#### 7. Head Teacher Report

The Head Teacher presented the report. The Head Teacher reported that the on roll numbers look bleak, especially for Marsham against capacity. Attendance is also an issue at both schools with lots of illness.

The Chair of the Management Committee asked if attendance falls in line with other Clusters schools? The Head Teacher commented that the Attendance lead has recently attended an attendance session, however feedback is pending.

The large number of pupil premium and SEND at Marsham, was noted.

A lengthy discussion ensued regarding PAN for Governors to agree. The Head Teacher noted that the placement officer at County and the categorisation partner looked at the forecast. Governors agreed to keep PAN at 15 for Hevingham and 5 for Marsham.

The Head Teacher confirmed that Teacher performance management has been complete and the Head Teacher will complete TA's next term.

The Chair of the Teaching and Learning Committee asked what the definition of Persistent Absence is? The Staff Governor noted attendance under 90%. The Co-opted Governor asked if all persistent absentees will attend an attendance panel. The Head Teacher confirmed that each pupil is looked at on a case by case basis, however we tend to monitor pupils under 90% and under 80% will have an attendance panel.

8.	Safeguarding	
	The Head Teacher confirmed that a half term newsletter has been initiated for staff on relevant topics. We have also received teacher resources for addressing violence against women and children.	
	The Chair of the Teaching and Learning Committee asked what County suggests if the settings have only one DSL. The Head Teacher confirmed that other DSL's in the Cluster can support and the new Nurture Lead will train as DSL, however the earliest training is March 2023. A discussion ensued about teacher capacity.	
	The Head Teacher confirmed that next week is assessment week and teachers are completing updated Boxall profiles - this will allow pupils to be identified for the nurture lead to prioritise.	
	The Head Teacher noted that no formal complaints have been raised, there have been some unrest at Marsham, however the Head Teacher is working informally with the team to find a resolution.	
	The Head Teacher noted that an advert has been circulated for a Parent governor and it was noted the new Class 2 teacher has been appointed and the children were very engaged and learnt something new at the end of her lesson.	
	Governors took this opportunity to thank the Head Teacher for their hard work and commitment to fill all staff vacancies.	
9.	Health and Safety	
	The Staff Governor confirmed they have completed the annual checks at Marsham and concerns noted including finger protection and looking at alternative solutions and the fire door in the kitchen.
